**RESOLUTION NO. 2019 - 276**

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FAIRFIELD ALLOWING THE CITY OF FAIRFIELD TO HIRE JUDITH MIRON AS A PART-TIME PAYROLL SPECIALIST SENIOR AS A PERS ANNUITANT WITHOUT A SIX-MONTH BREAK IN SERVICE**

**WHEREAS**, Judy Miron has the specialized skills and knowledge related to the duties and responsibilities of the Payroll Specialist Senior; and

**WHEREAS**, Judy Miron will be retired as the Payroll Specialist Senior as of December 2, 2019; and

**WHEREAS**, there is no recruitment at this time for the Payroll Specialist Senior; and

**WHEREAS**, the City of Fairfield is in need of Ms. Miron specialized skills and knowledge on a temporary, limited term basis.

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF FAIRFIELD HEREBY RESOLVES:**

Section 1. Judy Miron can be appointed by the City of Fairfield as a part-time Payroll Specialist Senior as a PERS annuitant without a six-month break in service.

Section 2. Judy Miron's appointment as the Payroll Specialist Senior as a PERS retired annuitant is done in accordance with all other PERS requirements and restrictions related to the appointment of retired-annuitants including, but not limited, to the following

- (a) Limited, Temporary appointment under Government Code Section 21224(a) due to Ms. Miron's specialized skills and experience;
- (b) Appointment term is from December 3, 2019, through June 30, 2021, and her appointment will not exceed 960 hours in a fiscal year;
- (c) Compensation is set at the Step 5 rate on the publicly available salary schedule for the Payroll Specialist Senior position of \$35.71 per hour;
- (d) Not eligible for nor will she receive any additional benefit or incentive such as paid time off or health and welfare benefits during her temporary, limited term appointment; and
- (e) She has verified that she has not received unemployment insurance within twelve months of this appointment.

Section 3. Judith Miron's appointment is on a temporary, limited term basis until June 30, 2021, until a new Payroll Specialist Senior is hired.
