RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FAIRFIELD APPROVING
THE PLANS AND SPECIFICATIONS AND AWARDING A CONTRACT TO FBD
VANGUARD CONSTRUCTION, INC. FOR THE GREEN VALLEY ROAD BAY AREA
RIDGE TRAIL CROSSING PROJECT AND UPDATING THE FISCAL YEAR
2020/2021 BUDGET

WHEREAS, the City of Fairfield ("City") advertised on June 1, 2020 to solicit proposals to construct the Green Valley Road Bay Area Ridge Trail Crossing Project; and

WHEREAS, the bid opening for the Green Valley Road Bay Area Ridge Trail Crossing was on June 23, 2020; and

WHEREAS, the apparent low bidder was FBD Vanguard Construction, Inc. in the amount of \$241,072; and

WHEREAS, staff has reviewed the bid documents from FBD Vanguard Construction, Inc. and found them to be in order; and

WHEREAS, staff is recommending that the City Council award the contract to FBD Vanguard Construction, Inc. as the lowest responsive and responsible bidder.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF FAIRFIELD HEREBY RESOLVES:

- Section 1. The above recitals are true and correct and are a substantive part of this Resolution.
- Section 2. The City Council hereby approves the plans and specifications for the Green Valley Road Bay Area Ridge Trail Crossing Project.
- Section 3. The City Council hereby authorizes and directs the City Manager to enter into a contract with FBD Vanguard Construction, Inc. for the Green Valley Road Bay Area Ridge Trail Crossing in the amount of \$241,072.
- Section 4. The City Council hereby further authorizes the City Manager to enter into an escrow agreement for security deposits in lieu of retention for the agreement authorized by this Resolution, if necessary.
- Section 5. The City Manager is hereby authorized to implement the above-mentioned contract.

Section 6. The City Council hereby approves that appropriation of \$64,180 in unrestricted fund balance in Fund 051 - Gas Tax transferred to Fund 252 Streets Capital Project, Division and Responsibility Code 99519 for the Green Valley Road Bay Area Ridge Trail Crossing.
