RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FAIRFIELD ALLOWING THE CITY OF FAIRFIELD TO HIRE WADE BROWN AS A PART-TIME CONSULTANT AS A PERS ANNUITANT WITHOUT A SIX-MONTH BREAK IN SERVICE

WHEREAS, in compliance with Government Code section 7522.56 the City Council of the City of Fairfield must provide CalPERS this certification resolution when hiring a retiree before 180 days has passed since his or her retirement date; and

WHEREAS, Wade Brown retired from City of Fairfield in the position of Financial Services Manager, effective October 2, 2020; and

WHEREAS, Wade Brown has specialized skills and knowledge required for upcoming high priority projects; and

WHEREAS, section 7522.56 requires that post-retirement employment commence no earlier than 180 days after the retirement date without this certification resolution; and

WHEREAS, section 7522.56 provides that this exception to the 180-day wait period shall not apply if the retiree accepts any retirement-related incentive; and

WHEREAS, the City Council of the City of Fairfield hereby appoints Wade Brown as an extra help retired annuitant to perform the duties of a Consultant at the Financial Services Manager level for the City of Fairfield under Government Code section 21224, effective October 21, 2020; and

WHEREAS, no matters, issues, terms or conditions related to this employment and appointment have been or will be placed on a consent calendar; and

WHEREAS, the employment shall be limited to 960 hours per fiscal year; and

WHEREAS, the hourly rate paid to Wade Brown will be \$70.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF FAIRFIELD HEREBY RESOLVES:

Section 1. Wade Brown can be appointed by the City of Fairfield as a part-time Consultant as a PERS annuitant without a six-month break in service.

Section 2. Wade Brown's appointment as Consultant as a PERS retired annuitant is done in accordance with all other PERS requirements and restrictions related to the appointment of retired annuitants including, but not limited to the following:

- (a) Limited, temporary appointment under Government Code Section 21224(a) due to Mr. Brown's specialized skills and experience;
- (b) Appointment term is from October 21, 2020 through June 30, 2021 and his appointment will not exceed 960 hours;
- (c) Compensation is set at the Step 10 rate on the publicly available salary schedule for the Consultant position of \$70.000 per hour;
- (d) Mr. Brown is not eligible for nor will he receive any additional benefit or incentive such as paid time off or health and welfare benefits during his temporary, limited term appointment; and
- (e) Mr. Brown has verified that he has not received unemployment insurance within twelve months of this appointment.

Section 3. Wade Brown's appointment is for extra help on a temporary, limited term basis to work on specialized projects (FLSA compliance and labor negotiations support).
