- CCC Associates will provide cannabis delivery services.
- CCC Associates anticipates opening for business 9 months after receiving City approvals.
- Projected number of customers:
 - \circ 9 11 per hour
 - 115 145 per day
- CCC Associates proposes 2 point of sale systems.
- CCC Associates currently operates one retail location in Long Beach, CA.

- CCC Associates has received City approvals to operate 9 additional retail businesses which have not yet opened to the public.
- CCC Associates are currently involved in the application process in the Cities of Porterville, Pomona, Oxnard, and Tracy.

LABOR & LOCAL ENTERPRISE PLAN

- CCC Associates anticipates hiring 30 40 employees.
- Compensation:
 - General Manager \$33.00 \$37.41
 - Assistant Manager \$24.00 \$27.21
 - Inventory Manager \$20.00 \$22.67
 - Budtender \$17.50 \$19.84
 - Delivery Personnel \$16.00 \$18.14

- Medical, dental & vision insurance benefits will be offered to all employees.
- Employees will receive a 401k, tuition reimbursement, vacation accrual, sick leave, and day care assistance.
- CCC Associates has a goal to hire a minimum of 75% of staff from within the City of Fairfield.

SAFETY PLAN

• A safety plan was assessed by Raul Angulo, a retired Fire Captain for the Seattle Fire Department.

SECURITY PLAN

- A security plan was prepared by Ridgeline OST, a security consulting firm located in California.
- CCC Associates will contract with Alpha Alarms and Audio, a licensed third-party security monitoring company, to monitor the real-time alarm system.
- CCC Associates plans to contract with Delta 1 Security, a third-party security guard provider located in Fairfield.
- CCC Associates will staff 5 6 armed uniformed security guards during operating hours and does not propose any security guards during off-hours.

LOCATION

- CCC Associates proposes to locate their business at 4455 Central Way and has provided property owner consent.
- The current zoning classification for the subject property is CR (Regional Commercial).
- Commercial cannabis retail is a permitted use in the CR zone subject to the

requirements of the Fairfield Municipal Code (FMC) Chapter 10E.

- The City has not identified any sensitive uses, as defined in FMC Section 10E.18 (c), within 600 feet of the subject property at the time of this writing.
- The subject site is located at the Cordelia Junction, adjacent to Interstate 80 and the 80/680/12 interchange and is accessed from the Suisun Valley Road/Pittman Road exit.
- The business is proposed in a 1,443 square foot unit within an existing multi-tenant building. Existing tenants in the building include a dental office, salon, and restaurant.
- There are 27 parking spaces on site. The site does not currently meet parking requirements to support a retail cannabis business. A detailed analysis of the floor plans of the existing businesses and their operating status will be required to determine if there is excess parking available to serve a retail cannabis business.

COMMUNITY RELATIONS PLAN

- CCC Associates will create a Culture Community program to facilitate company community outreach efforts. It is unclear if this will be a separate on-profit entity.
 - Culture Community proposes a board made up of CCC Associates employees, members of City staff, City Council members, and representatives of local organizations.
 - CCC Associates will provide Culture Community 2% of gross retail profits annually and an additional \$25,000.00 in the first year of operations.
- CCC Associates has committed to partnering with and provided initial contributions to the following Fairfield organizations:
 - Community Action North Bay provided an initial contribution of \$500.00.
 - St. Stephen CME Church provided an initial contribution of \$2,000.00 and will provide a DARE program sponsored by CCC Associates.
 - The Courage Center 2 provided and initial contribution of \$500.00.
- CCC Associates will create a youth incubator program to provide mentorship from CCC Associates employees and local volunteers.
- CCC Associates does not provide details for an educational program for youth organizations and/or to educational institutions in the community, related to the risks of youth addiction to cannabis and available resources related to drugs, drug addiction, and prevention, as required under Review Criteria 7 of the "Application Procedures & Guidelines for a Commercial Cannabis Business Permit".
- Application lists numerous potential partner organizations and programs within the City, no specific partner has been identified. It is unclear if these organizations have been contacted by CCC Associates.
- CCC Associates will provide wellness education programs for seniors and a paid bus service for visits to the retail store.
- CCC Associates will sponsor two homeless individuals per month and pay for their

essential needs.

• CCC Associates will create a homeless incubation program and provide activities for homeless youth.
