RESOLUTION NO. 2021-185

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FAIRFIELD APPROVING THE PLANS AND SPECIFICATIONS, RELIEVING TRINET CONSTRUCTION INC. OF ITS BID, AND AWARDING A CONTRACT TO VALENTINE CORPORATION FOR THE NELSON HILL RESERVOIR MIXING AND VALVE REPLACEMENT PROJECT AND UPDATING THE FISCAL YEAR 2021/2022 BUDGET

WHEREAS, the bid opening for the Nelson Hill Reservoir Mixing and Valve Replacement Project took place on June 15, 2021; and

WHEREAS, Trinet Construction, Inc. submitted the apparent low bid but requested withdrawal of bid and return of its bid security; and

WHEREAS, based on the City's review of the facts presented by Trinet, the City has determined that Trinet is eligible for such relief pursuant to Public Contract Code Section 5103; and

WHEREAS, Valentine Corporation is the next lowest responsive and responsible bidder in the amount of \$2,697,369; and

WHEREAS, staff has reviewed the bid documents from Valentine Corporation and found them to be in order; and

WHEREAS, staff is recommending that the City Council award the contract to Valentine Corporation, Inc. as the lowest responsive and responsible bidder; and

WHEREAS, funding was not allocated in the City's approved 2020-2021 Budget thus requiring a revision to add \$1,601,975 to cover the remaining cost of the project; and

WHEREAS, the revised appropriation constitutes an update to the 2021-2022 Budget approved pursuant to Resolution No. 2021-126.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF FAIRFIELD HEREBY RESOLVES:

Section 1. The plans and specifications for the Nelson Hill Reservoir Mixing and Valve Replacement Project are hereby approved.

Section 2. Trinet Construction, Inc. is relieved of its obligation to perform work related to the project for the bid amount without forfeiture of bid security.

Section 3. The city manager is authorized to enter into a contract with Valentine Corporation for the Nelson Hill Reservoir Mixing and Valve Replacement Project in the amount of \$2,697,369.

Section 4. The public works director is hereby authorized to execute and administer change orders for an amount not-to-exceed 15% of the above contract amount.

Section 5. The city manager is authorized to enter into an escrow agreement for security deposits in lieu of retention for said contract, if requested by the contractor.

Section 6. The council hereby approves that appropriation of \$1,601,975 unrestricted fund balance in Fund 462 for the Nelson Hill Reservoir Mixing and Valve Replacement Project, division and responsibility code 99363.
