

# CITY OF FAIRFIELD CITY COUNCIL REGULAR MEETING TUESDAY, MAY 4, 2021; 6:00 PM VIA TELECONFERENCE

## MINUTES

# CALL TO ORDER

Mayor Harry T. Price called the meeting to order at 6:12 p.m.

## **ROLL CALL**

On roll call were Councilmembers Pam Bertani, Cat Moy, Doriss Panduro, Chuck Timm, and Scott Tonnesen; Vice-Mayor Rick Vaccaro, and Mayor Price.

## INVOCATION

There was no invocation due to the Pastor being absent.

## PLEDGE OF ALLEGIANCE

Councilmember Timm led the Pledge of Allegiance.

## **COUNCIL REPORTS**

Vice-Mayor Vaccaro made a motion requesting that item 7 be continued to the May 18, 2021, Council meeting. Councilmember Moy seconded the motion. By a roll call vote, the motion carried unanimously.

Councilmember Bertani passed on giving a report. She made a motion asking that all items, except for cannabis item 10, be continued to May 18, 2021. Councilmember Moy seconded the motion. By a roll call vote, the motion failed 3-4, with Councilmembers Timm and Tonnesen, Vice Mayor Vaccaro, and Mayor Price voting no.

Vice-Mayor Vaccaro made a second motion to remove everything from the agenda, except items 7 and 10. Councilmember Moy seconded the motion. By a roll call vote, the motion passed unanimously. This motion overrode the first motion to continue item 7.

## **CITY MANAGER REPORT**

City Manager Stefan Chatwin recommended that since Solano County is still in the Red Tier regarding COVID-19, that the May 18, 2021 council meeting be held virtually via Zoom.

## CITY ATTORNEY REPORT

City Attorney Greg Stepanicich reported that during closed session, council unanimously voted to settle the Nevarez vs. City of Fairfield case, in the amount of \$22,000 to settle the case.

#### **CITY CLERK REPORT**

City Clerk Karen Rees reported that the City was accepting applications for openings on the Youth Commission, Planning Commission, and Rockville Hills Regional Park Citizens Advisory Committee.

Councilmember Timm made a motion to approve the Consent Calendar as presented. Councilmember Bertani seconded the motion. By a roll call vote, the motion carried unanimously. City Manager Stefan Chatwin reported he had conferred with staff and stated that Items 5, 6, 8, and 9 could be continued to May 18, 2021 Council meeting, at Council's discretion.

Councilmember Moy made a motion to continue item 5, and public hearings on items 6, 8, and 9 to the May 18, 2021, Council meeting. Councilmember Timm seconded the motion. By a roll call vote, the motion carried unanimously.

After public comment, each of the 14 cannabis retail permit applicants gave a two-minute rebuttal. They spoke in alphabetical order:

Brian Mitchell of Authentic Fairfield LLC; Chris Francy of CCC Associates of Fairfield (Culture Cannabis Club); Daniel Wise of Community Veterans of Fairfield; Darren Dykstra of East of Eden North Bay LLC; Josh Black of Element 7 Fairfield; Hayley Andrew of Fairfield Cannabis Collective; Rajan Dave of Fairfield Erudite Ventures (HerbNJoy); Chris Hester of Horizon Fairfield LLC; Jim Inglebright of J.J.V.I. Enterprises (The Bright Spot); Lauren Carpenter of Responsible and Compliant Retail LLC (Embarc); Dan Sharp of The Showcase LLC; Amy Jenkins of SPCF LLC (Sparc); Alida Lehman of 3 Bros Fairfield; and Juan Garcia Flores of Walkerville Lake Corp Clinica Center.

# Vice Mayor Vaccaro called for a ten-minute recess at 10:55 p.m. Council reconvened at 11:05 p.m.

Each Councilmember shared their top four candidates:

Councilmember Tonnesen – JJVI, Embarc, The Showcase, CCC (Culture) Councilmember Timm – JJVI, Embarc, The Showcase, Authentic Fairfield Councilmember Panduro – CCC, JJVI, Embarc, The Showcase Councilmember Bertani – JJVI, Embarc Councilmember Moy – JJVI, Authentic, Embarc, CCC Vice Mayor Vaccaro – Authentic, JJVI, Embarc, The Showcase

Councilmember Moy stated she had concerns with applicant, The Showcase, and said her concerns were based on documents she compiled. City Manager Chatwin asked her to forward all documents to him and he would distribute them to City Attorney Stepanicich and each councilmember for review. City Attorney Stepanicich stated that The Showcase would be given time at the next council meeting to address the concerns raised by Councilmember Moy.

After a lengthy discussion, Councilmember Moy made a motion to allow up to three permits. Councilmember Bertani seconded the motion. The motion failed 2-4, with Councilmembers Panduro, Tonnesen, and Timm; and Vice Mayor Vaccaro voting no.

Councilmember Tonnesen made a motion to allow up to four permits. Councilmember Timm seconded the motion. By a roll call vote, the motion carried unanimously.

After lengthy discussion, Councilmember Tonnesen made a motion to award preliminary approval to JJVI, Embarc, and The Showcase. Councilmember Timm seconded the motion. The motion failed 3-3, with Councilmembers Bertani, Moy and Panduro voting no.

After more discussion, Councilmember Moy made a motion to award preliminary approval to JJVI and Embarc, as they each received 6 votes. Councilmember Timm seconded the motion. The motion carried unanimously.

Upon further discussion, Councilmember Timm made a motion to agendize Authentic LLC, The Showcase, and CCC (Culture Cannabis Club) at the May 18, 2021 council meeting to discuss and determine if any of these applicants shall be given preliminary approval for a retail cannabis permit. Councilmember Tonnesen seconded the motion. By a roll call vote, the motion carried unanimously.
