RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FAIRFIELD APPROVING THE PLANS AND SPECIFICATIONS AND AWARDING A CONTRACT TO MARINA LANDSCAPE, INC. FOR THE GATEWAY BOULEVARD MEDIAN ISLAND MODIFICATION PROJECT AND UPDATING THE FISCAL YEAR 2021/2022 BUDGET

WHEREAS, the bid opening for the Gateway Boulevard Median Island Modification Project took place on July 20, 2021; and

WHEREAS, Marina Landscape, Inc. is the lowest responsive and responsible bidder in the amount of \$186,876; and

WHEREAS, staff has reviewed the bid documents from Marina Landscape, Inc. and found them to be in order; and

WHEREAS, staff is recommending that the City Council award the contract to Marina Landscape, Inc. as the lowest responsive and responsible bidder; and

WHEREAS, funding was not allocated in the City's approved 2021-2022 Budget thus requiring a revision to add \$135,564 to cover the remaining cost of the project; and

WHEREAS, the revised appropriation constitutes an update to the 2021-2022 Budget approved pursuant to Resolution No. 2021-126.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF FAIRFIELD HEREBY RESOLVES:

- Section 1. The plans and specifications for the Gateway Boulevard Median Island Modification Project are hereby approved.
- Section 2. The city manager is authorized to enter into a contract with Marina Landscape, Inc. for the Gateway Boulevard Median Island Modification Project in the amount of \$186,876.
- Section 3. The public works director is hereby authorized to execute and administer change orders for an amount not-to-exceed 10% of the above contract amount.
- Section 4. The city manager is authorized to enter into an escrow agreement for security deposits in lieu of retention for said contract, if requested by the contractor.

Section 5. The council hereby approves that appropriation of \$135,564 unrestricted fund balance in Fund 061 transferred to Fund 252 Street Capital Projects for the Gateway Median Island Modification Project, division, and responsibility code 99375.
