**RESOLUTION NO. 2019 - 275**

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FAIRFIELD SETTING A PUBLIC HEARING FOR HEARING AND COMMENTS ON THE PROPOSED ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FAIRFIELD AMENDING CHAPTER 8 (FIRE PROTECTION) OF THE FAIRFIELD CITY CODE, ADOPTING BY REFERENCE CALIFORNIA CODE OF REGULATIONS, TITLE 24, PART 9, KNOWN AS THE 2019 CALIFORNIA FIRE CODE, WITH AMENDMENTS TO REFLECT LOCAL CONDITIONS, AND ADOPTING BY REFERENCE CERTAIN PORTIONS OF THE 2018 INTERNATIONAL FIRE CODE**

**WHEREAS**, California Health and Safety Code Sections 17958, 17958.5, 17958.7 and 18941.5 allow the City, by ordinance, to make modifications or changes to the California Building Standards Code in Title 24 of the California Code of Regulations; and

**WHEREAS**, California Government Code Section 50022.3 requires the legislative body to schedule a public hearing “[a]fter the first reading of the title of the adopting ordinance and of the title of the code to be adopted thereby, and of the title of the secondary codes therein adopted by reference”; and

**WHEREAS**, notice of the public hearing must be published pursuant to California Government Code Section 6006; and

**WHEREAS**, California Government Code Section 6006 requires two publications providing notice of the public hearing, with the “period of notice commenc[ing] upon the first day of publication and terminat[ing] at the end of the fourteenth day, including therein the first day,”

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FAIRFIELD:**

**SECTION 1:** The City Council of the City of Fairfield does hereby announce its intention to consider adoption of an Ordinance entitled: “ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FAIRFIELD AMENDING CHAPTER 8 (FIRE PROTECTION) OF THE FAIRFIELD CITY CODE, ADOPTING BY REFERENCE CALIFORNIA CODE OF REGULATIONS, TITLE 24, PART 9, KNOWN AS THE 2019 CALIFORNIA FIRE CODE, WITH AMENDMENTS TO REFLECT LOCAL CONDITIONS, AND ADOPTING BY REFERENCE CERTAIN PORTIONS OF THE 2018 INTERNATIONAL FIRE CODE” (the Ordinance). The Council will also consider adoption of a Resolution which sets forth the local conditions upon which a determination will be made by the City Council that modifications to Chapter 8 adopting the uniform codes are reasonable and necessary to protect the public health, safety, and welfare of the community (the “Resolution”).

**SECTION 2:** The City Council hereby waives the first reading of the Ordinance in full and approves reading by title only and sets a public hearing for December 3, 2019 at 6:00 p.m., in the Council Chambers of the Civic Center, 1000 Webster Street, City of Fairfield, California, or as soon thereafter as the matter may be heard, to hear the comments of the public on said ordinance and the uniform codes to be adopted thereby and on the adoption of said Ordinance and Resolution. Pursuant to California Government Code Section 6066, Notice of the Public Hearing shall be published in the Daily Republic in accordance with California Government Code Section 6006.

**SECTION 3:** Copies of the codes proposed to be adopted by reference and described in Section 1 of this Resolution as well as copies of the proposed codes, Ordinance and Resolution described in Section 1 of this Resolution are on file in the Office of the City Clerk and are available during the office hours of the City Clerk for public inspection.
